UNOPPOSED MOTION TO EXTEND DEADLINE
THROUGH SEPTEMBER 8, 2025 (FINAL EXTENSION)

COMES NOW Appellant, Carly Madison Gregg a/k/a Carley Madison Gregg, by and through counsel, and respectfully moves this Court for a short, final extension of time to file the principal brief, Record Excerpts, and all accompanying materials through Monday, September 8, 2025. In support, Appellant states:

1. Under the previous briefing schedule, Appellant's brief was due August 29, 2025. Appellant timely filed an unopposed motion seeking an extension through September 2, 2025. According to the Clerk of Court, an order granting that request has not yet been entered.
2. Appellant now requests a brief additional extension through September 8, 2025. This is a final request; Appellant will seek no further extensions.
3. Good cause exists for this brief, final extension. This appeal involves multiple issues and a multi-volume record requiring precise transcript citations and careful preparation of MRAP-compliant record excerpts (see MRAP 28 & 30). A few additional days will ensure a clean, accurate submission that will aid the Court and will not prejudice the State.

3. Counsel has conferred with Appellee; the State does not oppose this request.
4. This brief extension is sought in good faith and not for delay. It will aid the Court by ensuring a clean, properly cited brief and excerpts while causing no prejudice to Appellee.

WHEREFORE, PREMISES CONSIDERED, Appellant respectfully requests that the Court enter an order (i) extending the deadline to September 8, 2025 for filing the principal brief, Record Excerpts, and all accompanying materials; (ii) deeming any such filings timely if made on or before that date; and (iii) granting such other and further relief as the Court deems just and proper.
